OVERVIEW

- The renaming of certain school sites is part of the District's work in dismantling racism from within our system.
- Education Code and Board Policy.
- The District currently has various school sites that contain the names of individuals that perpetuated or condoned racism, oppression, and exclusion.
- Staff recommend focusing on these sites during our initial effort:
 - Kit Carson International Academy
 - Sutter Middle School
 - Peter Burnett Elementary

PROCESS

- 1. Board's approval of creating an ad hoc Community Advisory Committee.
- Receive appointments from each Board Member and Superintendent.
- Develop a community announcement and survey to gain broader community input.
- 4. Confirm meeting dates and times with Committee members.
- 5. Develop meeting materials and conduct virtual meetings through the winter.
- 6. Come to the Board for a public hearing on this topic at the February 18 Board Meeting, with Board action at a subsequent meeting.

- October 15 the Board announces renaming committee.
- October 29 Virtual pre-meeting with Principals Zoom
- **November 10 –** Virtual community meeting to discuss one site name change
- **December 1 –** Virtual community meeting to discuss one site name change
- **December 8 –** Virtual community meeting to discuss one site name change
- January 14 Virtual community meeting to review the three name changes and begin preparing recommendation to the Board of Education
- **February 18** Public Hearing at Board Meeting with action to follow at subsequent meeting
