Kaiser – July 2020 Renewal Negotiations

Request submitted to request rate relief on the 12.29% increase – Kaiser leadership declined the request for the following reasons:

- The 12.29% reflects the claims experience of the group (12.70%)
- The Kaiser plans are the low cost plans by a significant margin vs Health Net
- Employee contributions do not reflect the affordability that Kaiser offers
- Possibility of district moving to a pooled arrangement
