Driving Governance

Assembly Bill (AB) 130 (2021)

- Requires any local educational agency (LEA) operating a Kindergarten to also provide a TK program for all 4-year-old children by 2025–26.
- Full day learning program through partnerships with expanded learning offerings:
 - After School Education and Safety Program
 - The CA State Preschool Program,
 - Head Start Program
 - Other community-based early learning and care programs

Proposed Policy Revision - Overarching

Changed language from Early Kindergarten (EK) to Transitional Kindergarten (TK)



Proposed Policy Revision - Eligibility

2021-22 - TK offered to 4-year-olds who turn 5 between September 2 and Dec 2





Proposed Policy Revision - Out of District Transfers

Out of District TK students may be admitted to SCUSD TK to allow for continuity of service



Proposed Policy Revision - Waivers

- Over-Age TK Waiver: for children whose fifth birthday is on or before September 1 and who is therefore eligible for kindergarten.
- Under-Age TK Waiver:
 - o fifth birthday is between April 2, 2024 and September 1, 2024 for the 2023-24 school year
 - o fifth birthday between June 2, 2025 and September 1, 2025 for the 2024-25 school year.
- Special Under-Age TK Waiver:
 - Children who are eligible for the Under-Age TK Waiver
 - Active IEP
 - Sibling at a site with TK

Proposed Policy Revision - Curriculum and Instruction

Commingling

- TK and Preschool Students
- Must meet the requirements of TK and Preschool Programs
 - DRDP Administration
 - Early Childhood Environment Rating Scale Administration
 - Adult Child Ratio for TK and Preschool (10:1/8:1)

Proposed Policy Revision - Continuation to Kindergarten

- Kindergarten Continuance Form
- Requires parents/guardians of students in TK under the "Over-age Waiver" to complete a kindergarten continuance form

Next Steps

- Bring policy back to Board for a 2nd Reading March 16
- Bring policy to the Board for approval April 13
- Revise the Administrative Regulations
