Mission Statement: The mission of Hollywood Park Elementary School is to provide Rigorous Instructional Practices, promote Parent and Community Engagement, and maintain a positive School Culture and Climate.

- **Rigorous Instructional Practices:** In order for our students to be college and career ready, we provide rigorous instructional practices. All teachers are GATE Certified and differentiate instruction in their classroom to meet the needs of all students. Teachers have implemented the Common Core State Standards and provide challenging instruction using technology and higher-order thinking activities. Teachers plan and implement engaging lessons that provide students with opportunities to work collaboratively.
- **Parent and Community Engagement:** With parents as our partners, we can support student achievement. The Parent Resource room provides education courses that help parents to understand how to support their students and learn about their school community. Our PTO encourages parent involvement and provides enrichment opportunities for our students and school community. The ELAC meet regularly to provide input on services to meet the needs of our bilingual students.
- **School Culture and Climate:** Through the implicit instruction of Character Education (Word of the Week and the Second Step curriculum) and Social Emotional Learning (SEL), students learn the importance of respect and responsibility. SEL provides students opportunities to explore self-awareness, social awareness, responsible decision-making, relationship skills, and self-management. The Hollywood Park Parent Teacher Organization (PTO) support the creation of a positive learning environment through assemblies, social events, campus beautification, and parent engagement opportunities. California State University Sacramento CSUS partners with HPE to provide relevant, meaningful, and interactive lessons on SEL competencies each week.

Our mission will be achieved through the Balanced Literacy approach to Language Arts instruction and by providing a rigorous, CCSS-aligned curriculum that enables all students to meet their learning objectives, ensure that all teaching is effective and meets the needs of all students, empowers students to take ownership of their learning, creates a positive learning environment where everyone feels that they are stakeholders in the school community, and by involving parents in their children's education through open, ongoing communication.

Hollywood Park Elementary School is a small, neighborhood school that is culturally diverse. We have a cohesive staff that work collaboratively to provide exciting and creative lessons in English Language Arts, Math, Social Studies, Science, Physical Education, and Art. School Facility Conditions and Planned Improvements (Most Recent Year)

Hollywood Park Elementary School, built in 1956, received Facility Inspection Tool (FIT) overall repair rating score of “good” from its most recent facility inspection in June 2018. The district governing Board has adopted cleanliness standards for all district schools to ensure that all schools are clean, safe and functional. The district Operations Department takes great pride following a work order process that provides efficient and timely services to all the sites. The principal works directly with the site custodial staff to develop cleaning schedules to ensure that the school is clean and safe.

The passage of Measure Q, the district’s 2012 general obligation bond, provided facility upgrade funding to all district schools. The district performed Quick Strike projects during the summer of 2014, which allowed schools to pick from one of the following improvements: 1) marquees, 2) closed-circuit television (CCTV) surveillance, 3) exterior painting, or 4) seal coating and striping of parking lots or playgrounds. Fire alarms at all the district schools were upgraded. Additional 10 million dollars have been allocated for safety and security upgrades, which are expected to begin in 2019.

Funding from the federal government through Universal Service Administrative Company (USAC) provided for technology infrastructure improvements to the district’s wireless connectivity. The improvements, which are expected to be completed by the end of 2019, will increase classroom internet access and digital voice communication.

Professional Development provided for Teachers

To realize the vision of Sacramento City Unified School District, which is to fully prepare all students for college and career, it is imperative that the district provides numerous opportunities to expand the professional repertoire of its administrators and teachers.

To that end, the district has crafted a high quality professional program that is focused on Literacy (including ELA Common Core Standards), English Language Learners, Differentiation of Instruction, Data Inquiry, Culturally and Linguistically Teaching and Learning, and Conceptual Understanding of Mathematics. The learning opportunities afforded through this program deeply align with the needs of our individual schools, as well as our strategic plan, and connect to every aspect of school practice: thinking curriculum, intentional instructional practices, assessment for learning, and lesson design.

Professional learning opportunities are offered during school hours and outside of contracted hours. In addition to on-site coaching and regular professional learning opportunities, a designated collaborative Thursday time provides the opportunity for teachers to engage in collaborative professional learning at their respective schools focusing on deepening their content knowledge, strengthening their instructional repertoire, improving their assessment strategies, and fostering a shared sense of responsibility.
