School Description

Our Vision: All Students Will Achieve At High Levels

Where academic improvements are needed, the Pacific Staff and School Site Council have spent time analyzing and monitoring achievement data in order to make instructional adjustments for improving student outcomes. The following items reflect major components of the plan for improving academic achievement at Pacific School:

- Teachers collaborate in grade level or school-wide teams at least 1 time per week after school.
- Grade level teams have participated in 2-3 ELA Coaching Cycles and 2-3 Math Coaching Cycles with district training specialists. Also, Grade level teams regularly met with district ELA/Math training specialists during grade level CT.
- All students are eligible to receive Supplemental Educational Services (tutoring) and all students have access to grade level computer intervention (iReady & ST Math).

The process for the development of the 2018-2019 was collaborative and included the voice of all stakeholders. Below identified the dates and activities regarding budget planning:

1. 9/28/16...School Site Council, ELAC, and Safety Committee met as a group and reviewed and discussed 2018-19 SPSA, goals, and expenditures from General Fund, Title 1, LEP, and Free & Reduced. LCAP and school goals and costs were shared and discussed while considering goals and budget for 2018-19.
2. 11/30/16...School Site Council, ELAC, and Safety Committee met as a group and reviewed and discussed 2016-2017 LCAP balances in all categories and the alignment between site SPSA and the District Strategic Plan while considering the impact for 2017-2018 SPSA.
3. 12/14/16...School Site Council, ELAC, and Safety Committee met as a group and reviewed 2016-2017 budget balances and programs to continue to include in 2017-2018 budget.
4. 1/25/17...School Site Council, ELAC, and Safety Committee met as a group to evaluate EL student data and site EL program and need of continual support for professional development in ELD standards with district training specialists.
5. 1/31/17...SBDM...Team shared and discussed the school wide survey that ranked PI Intervention spending recommendations. Results recommended the removal of Reading Partners and continual of all other programs for 2017-2018.
6. 2/2/17...Staff Meeting...Staff looked at SES requirements and student assessments to recommend students to extended day tutoring with paid Pacific teachers to increase academic achievement in ELA/Math.
7. 2/2/17...Staff Meeting...Staff looked over 2017-2018 budget and focus of site programs based on staff, teacher, community, and family survey.
8. 2/16/17...Collaborative Time...Staff was trained on Illuminate to facilitate the sharing, analyzing and discussion of data and intervention strategies to increase academic achievement. Teachers worked in grade level teams to focus on grade level and individual classroom data to inform instructional planning.
9. 10/20/16, 1/19/2017...CT...Pacific staff participated in Social Emotional Learning (SEL) training and discussed strategies to continue Social Emotional Learning in the classroom to increase academic, social, and emotional achievement.
10. 4/25/18...SSC evaluated the 2017-2018 SPSA, made changes to develop 2018-19 SPSA and approved the new amended SPSA.

About the SARC

School Facility Conditions and Planned Improvements (Most Recent Year)

Pacific Elementary School, built in 1951, received Facility Inspection Tool (FIT) overall repair rating score of “good” from its most recent facility inspection in September 2018. The district governing Board has adopted cleanliness standards for all district schools to ensure that all schools are clean, safe and functional. The district Operations Department takes great pride following a work order process that provides efficient and timely services to all the sites. The principal works directly with the site custodial staff to develop cleaning schedules to ensure that the school is clean and safe.

The passage of Measure Q, the district’s 2012 general obligation bond, provided facility upgrade funding to all district schools. The district performed Quick Strike projects during the summer of 2014, which allowed schools to pick from one of the following improvements: 1) marquees, 2) closed-circuit television (CCTV) surveillance, 3) exterior painting, or 4) seal coating and striping of parking lots or playgrounds. Fire alarms at all the district schools were upgraded. Additional 10 million dollars have been allocated for safety and security upgrades, which are expected to begin in 2019.

Funding from the federal government through Universal Service Administrative Company (USAC) provided for technology infrastructure improvements to the district’s wireless connectivity. The improvements, which are expected to be completed by the end of 2019, will increase classroom internet access and digital voice communication.

Professional Development provided for Teachers

To realize the vision of Sacramento City Unified School District, which is to fully prepare all students for college and career, it is imperative that the district provides numerous opportunities to expand the professional repertoire of its administrators and teachers.

To that end, the district has crafted a high quality professional program that is focused on Literacy (including ELA Common Core Standards), English Language Learners, Differentiation of Instruction, Data Inquiry, Culturally and Linguistically Teaching and Learning, and Conceptual Understanding of Mathematics. The learning opportunities afforded through this program deeply align with the needs of our individual schools, as well as our strategic plan, and connect to every aspect of school practice: thinking curriculum, intentional instructional practices, assessment for learning, and lesson design.

Professional learning opportunities are offered during school hours and outside of contracted hours. In addition to on-site coaching and regular professional learning opportunities, a designated collaborative Thursday time provides the opportunity for teachers to engage in collaborative professional learning at their respective schools focusing on deepening their content knowledge, strengthening their instructional repertoire, improving their assessment strategies, and fostering a shared sense of responsibility.
