COVID-19

- COVID-19 continues to spread throughout our state and county, however our actions have slowed the spread
 - California: 85,977 cases and 3,497 deaths
 - Sacramento: 1,255 cases and 56 deaths
- All our actions save lives
 - People can spread the virus, even without symptoms
 - Stay home if you are sick
 - Stay home except for essential needs
 - If you go out, stay at least 6 feet away from others and wear a face cloth covering if possible
- Sacramento County moving into early Stage 2
 - Schooling remains remote at this time

School Closure Dashboard Development

- Staff have created a School Closure Dashboard to track key system processes from March 13th to the end of the school closure period
- Many of the indicators are first-time metrics requiring staff investment of time and process
- Key performance metrics include:
 - Student Engagement
 - Student Support
 - Social and Emotional Support
 - Graduation/College-Going
 - Academic Achievement
 - Human Resources
 - Food Services

Distance Learning Update

- Focus on Essential Standards CA Common Core
 - Content standards to be secured by the end of each grade level
- Teaching expectations in the distance learning space
 - Current percentage of students engaged in distance learning
 - What is currently being taught
 - How teachers are currently assessing students
 - Currently working on a more robust definition of staff "engagement"
- Sac City Kids Connect internet access update

Key Metrics

- Engagement (In development)
 - Creating an actionable definition for students, principals and teachers
 - Prioritizing "unreachable" students
 - Internet Access
- Student Support
 - Identification and supports for students through Early Identification and Intervention (EIIS) system
- Social and Emotional (In development)
 - Targeted questions to assess student connection
- Student graduation/college-going progress
 - On-Track for graduation/A-G completion and eligibility
 - College Applications
 - FAFSA Completion
- Academic Achievement
 - Letter Grades
 - District Common Assessments (if available)
- Human Resources
 - Key hiring support processes (e.g. payroll, credentials, leaves)
- Food Services
 - Meals Served


Pipeline Indicators

- Number and Percentage of students who are engaged during distance learning
- Number and Percentage of principals who are engaged during distance Learning
- Number and Percentage of teachers who are engaged during distance learning
- Number and Percentage of students without access to the internet
- Number and Percentage of families with a change in status to Free/Reduced lunch since March 1, 2020

Additional Modalities for Students to Reach Out for Support

SEL Check-in and a Collaborative Approach to Supporting Students

- Why: Social and emotional health are critical to engagement in distance learning and navigating Covid-19. Data will inform SEL supports needed now and for school re-entry.
- What: 4-item survey to check in with students and respond with targeted SEL supports?
- How: Students complete in Clever




How are you doing?

"How are you feeling?" SEL Survey

The 4-items:

- How have you been feeling?
- 2. How are you managing your emotions?
- 3. I have at least one adult that I can go to for help or support when needed.
- 4. I have at least one friend or peer that I can go to for help or support when needed.



Dashboard Case Study: "Unreachable" Students"

- 648 or 1.5% of EK-12th with whom we have had zero contact since 3/13/20 or who have had zero engagement in Distance Learning as of 5/4/20. *Was previously 1,636 two weeks ago!*
- Key student groups above 1.5% include homeless (9.3%)/27 students, Asian-Laotian (4.6%)/11, Foster Youth (2.9%)/8 students, African-American (2.6%)/150, English Learner (2.5%)/192 students, Asian (1.9%)/141, Special Education (1.6%)/141 students
- Highest percentage grade levels are: 8th (2.4%), 7th (2.3%), Kinder (2.0%) and 4th (1.7%)
- Highest number sites are: Rosa Parks K-8, CK McClatchy High,
 Pacific Elementary and Hollywood Park Elementary
- Approximately 74% of middle and high school unreachable students had a D or F at quarter 3 versus 22% of all students in CORE classes
