## Pupil Textbook and Instructional Materials Incentive Program Act

- Requires Public Hearing by 8<sup>th</sup> week of school to certify that all students have sufficient textbooks or instructional materials that are consistent with the content and cycles of curriculum frameworks adopted by the State Board of Education in the core subject areas
- Digital access to materials requires all students to have an electronic device and internet access

#### Steps to Ensure Sufficiency

- Survey Sites Textbook/Instructional Materials Needs
- Redistribute Surplus Textbooks
- Order Additional Textbooks
- Purchase Digital Access to Materials (if possible)
- Chromebook distributions
- Internet access
- Verify Materials
