



## Safety Intervention and Response (SIR)

**SIR Goal:** Promote Intervention and prevention through student engagement in an effort to Reduce the need for Discipline and mitigate Disparities that Increase Suspensions, Expulsions, Transfers, and Arrests Using Data-Driven Decision-Making to Respond and Intervene to Crisis and Students-in-Need.

- Equity & Access Agenda: to ensure all students have an equal opportunity to graduate with the greatest number of postsecondary choices. By reducing discipline disparities we can support successful student educational outcomes.
- Research and reports have shown that punitive measures have a negative effect on student outcomes. By developing restorative approaches to school safety, we can provide real alternatives.
- By focusing specifically on student groups who are receiving the most discipline disparities, we are ensuring an equitable approach for systemic change.

## Approach:

Approach to Safety understanding structural racism and concepts like the school-to-prison pipeline, not only in theory but how daily practices may be punitive or restorative

Work closely with families, community agencies, and other stakeholders to in corporate perspectives from marginalized groups by hosting meetings or presenting externally



Provide a model that aligns with social justice by building in staff positions dedicated to providing and encouraging restorative and preventative efforts at our campuses




Enhance campus safety by providing additional resources to campus administrators

#### **EMERGENCY AND CRISIS:**

Response to stabilize physical harm / safety concerns that would impact students and staff, ultimately reducing the issue to "non emergency".

#### **NON-EMERGENCY:**

District will coordinate resources to address these scenarios, adhering to due process, student / parent rights and mitigating liability.



## **School Administrator Guidance**

\*\*Safety Intervention and Response Coordination (SIRC)

#### Who does Admin call if we need support?

Admin calls **(916) 549-6899** to access SCUSD SIRC nonviolent de-escalation supports, for example:

- Severely escalated student, causing harm or danger
- Student running away from campus and their safety is in jeopardy (elopement)
- Fight that school personnel cannot subdue unassisted
- Unwelcome outsider(s) who do not disrupt operations or do not pose a potential safety issue entering campus
- · Need to issue stay away order
- · Wellness Check
- Situation in the neighborhood that appears to involve police
- Any other situation requiring immediate nonviolent de-escalation supports or when you're unsure if a situation might require law enforcement

## When would Admin call the SPD / SSD non-emergency line?

Admin calls SPD **(916) 264-5471** SSD **(916) 874-5115** 

non-emergencies, for example:

- To dispose of contraband or large amounts illegal drugs (note: the names of students need not be disclosed to police for disposal)
- If a serious crime is believed to have taken place (but is not currently in progress)

If a parent demands that the police be called, provide them the number so they may call themselves, unless the situation is a mandatory school notification of law enforcement, in which case the school administrator may call (refer to list of when to call 911).

## What if there's a mental health crisis?

- Admin should call site therapist, psychologist, social worker, or Student Supportive Services
- If student meets risk criteria, Admin contacts parent to request they transport student for assessment. If unable, call mobile crisis to conduct assessment

#### When would we call 911?

Call **911** whenever there is an imminent danger to someone's health or safety, for example:

- · Bomb threat/discovery of a bomb
- · Medical emergencies
- · Fire
- Serious injury (e.g., resulting from suicide attempt, violence, accident, etc.)
- · Drive-by shooting on school site
- Person shooting brandishing a gun or explosive
- · Armed robbery or hostage situation
- Abduction/kidnapping (observed or suspected)
- Major violent crime in progress (e.g., sexual assault, attempted murder, etc.)
- Emergency building evacuation (e.g., fire, hazardous materials/fumes, gas leak, etc.)
- Any operational failure that puts lives in danger (e.g., broken water, steam or gas lines)
- Any other situation posing an imminent danger to someone's health or safety

If 911 is called notify Safe Schools Director (916) 549-6899

## **GVS Process Re Imagined**

- Discontinued truancy sweeps. Referrals from SPD, dealing with gang-related issues or observed causation factors. Address sent to SCUSD, identify any students at that location, students assessed in our Early Identification Intervention System.

- Follow Up

## **Addressing Safety Gaps**

- · Report of crimes against students: <u>Safety Officers</u>
- Mental health crisis/5150 assessment Connection to M.H Services: <u>Safety</u> <u>Intervention and Response Coordinator</u>
- Respond to dangerous situations (Suspected Weapons) <u>Safety Officers; if</u> <u>necessary Law Enforcement</u>
- Supervision for large events <u>Community Organizations</u>, <u>Safety Officers</u>, <u>Sacramento County Probation Department (no cost)</u>, and <u>Sacramento Police</u> <u>Department</u>
- Emergency communication / Exchange of information: <u>Director of Safe Schools</u>
- Partners in safety planning CSSP: <u>Safety Officers / Law Enforcement</u>
- · Investigate threats to school safety: <u>Safety Officers</u>; if necessary Law Enforcement



## **Areas of Improvement**

- A clear understanding that Safety Re Imagined is a new and dynamic approach compared to the traditional operations Safe Schools.
- Not a replacement of the role of law enforcement.
- Inter District Collaboration: Improve the collaboration among departments with overlapping "Safety" interests.
- District is adding additional Safety Officer and/or Lead Campus Supervisor positions at each comprehensive high school due to staffing insufficiency
