5.0 2015-2016 Bond Reports

Elizabeth Sav from Crowe Horwath (external audit firm) presented the 2015-2016 Bond Audits to the Committee. These audits consist of a financial audit and a performance audit for Measures Q and R. Sacramento City Unified is in compliance with regards to both Measures Q and R. The Committee received copies of the audits and the audits will be posted to the SCUSD website.

6.0 Bond Fund Update

Staff presented to the Committee the quarterly accounting project reports ending April 30, 2017 and June 30, 2017. The reports will be posted on the SCUSD website.

Question: Are all class size reductions (CSR) complete? Answer: All classrooms have been placed. There is room for all students. SCUSD was able to use portables that we already owned. We did not need to purchase new ones.

Question: Is SCUSD still working on the Core Academic projects? Answer: The first year was, McClatchy, Kit Carson and West Campus. The second year (current) is, Johnson, Burbank and American Legion. Next year will be, Kennedy, Sac Charter High and Albert Einstein.

The work at most of the sites is more than a summer's work. The sites are aware that some construction will be going on during the school year.

The work (building) at West Campus will begin in the summer. The field will be complete by October 31, 2017.

SCUSD is in the process of working with Verde Design on a master plan for the 5 comprehensive high schools' athletic facilities. This process will also include an assessment for Sac Charter High and West Campus.

Question: Is the track at Kennedy being fixed? Answer: Yes, under warranty.

Question: Is there a way get an analysis of what an original contract price is versus what the project actually ended up costing? Answer: Yes. Through our accounting system.

All project costs are Board approved.

Committee members requested a report that would better represent project budgets than the current reports being used.
