Staff presented to the committee the e-builder Project Update Report and the Bond Program Status Report for period ending April 30, 2019.

Terra Bennet Brown: Beginning date of the bond? Fiscal year 2013-14. How many projects are not on the list anymore due to closeout? A lot.

Deferred Maintenance was a program that the State had up until about 2008. At the last recession, the Deferred Maintenance program went away. It was a way for the District to get funds from the State. In order to receive funds the District had to have a 5 year deferred maintenance plan. It identified major maintenance needed throughout the District in 13 categories.

Terra Bennet Brown: Does the Facilities Committee use it? The Facilities Committee can make recommendations.

SCUSD is preparing a new Facilities Master Plan. Part of the plan will include a Facilities Condition Assessment.

We would like a bond in 2020.

Staff will work on creating a closeout list with pictures.

Brian Hill: Does SCUSD figure up what the savings would be by closing a school? Yes.

Terrence Gladney: Will the firm have expertise in the whole craziness of our District with Waldorf public schools and our specialized programs that we've created to keep students in the District? Yes, everything will be discussed. Cathy Allen: Community involvement with this master plan will be critical whether the District is taken over or not.
