The Core Academic projects are our focus.

Technology was a high cost. But now all of our schools are wired.

CKM Phase II and the Kit Carson Project go to the Board tomorrow night at the Board meeting.

The West Campus project is in construction documents at this time.

All phases will be submitted to DSA prior to December 31, 2016 ahead of the code change.

There is \$2m allocated out of Measure R for a full size practice field at WCHS.

We have met with the principal at Hiram Johnson HS to begin the process of their Core Academic project.

They are still trying to narrow their scope down.

HJHS needs new HVAC.

Burbank and American Legion are next. We will be meeting with site staff shortly.

We held interviews for the Central Kitchen architect firm. We hired HMC Architects.

We are still conducting due-diligence on San Joaquin for the 16th and N property swap.

The next Bond sale is scheduled for this spring 2017 in the amount of approximately \$81,100.000(Q) and \$40.9m(R).

If there is anything left over from Measure R, we could use the funds for field repair.
