Reason for Reinstating Position	The Coordinator, Visual and Performing Arts coordinates the district's arts initiatives and programming. This includes the work of the 4.8 FTE Music teachers that provide music at the middle and high school levels. The coordinator is also responsible for the implementation of <i>Any Given Child</i> an Arts integration initiative that provides elementary school students with artist's residences and arts-focused experiences including arts assemblies, and Sacramento Youth Symphony partnership which supports students at Father Keith B Kenny and Caroline Wenzel in an afterschool strings music program. In addition, the coordinator is facilitating SCUSD's Arts Strategic planning process with community members and arts organization partners and a community of practice through a grant partnership with SCOE. The Coordinator, Visual and Performing Arts also develops and facilitates professional learning on arts integration for general and arts educators to expand access to quality arts instruction for SCUSD students.
