Q&A from Community Budget Meeting at Genevieve Didion K-8 School, October 23, 2013

QUESTION: How are those additional funds such as Title I used in the schools? What are the rules and regulations?

RESPONSE: Below are the guidelines for Title I, Economic Impact Aid/Limited English Proficiency (EIA – LEP), and Economic Impact Aid/State Compensatory Education (EIA –SCE).

2013-2014 SCUSD Categorical Funding Guide for Schools: Examples of Expenditures

Categorical Programs are programs for which **funding is restricted to specific purposes. These purposes are** governed by a unique set of laws and controlled by language found in the budget item governing the program. The chart below provides guidance on the use the each of the different categorical funding sources by suggesting possible uses which would be *determined based on your school's student data and School Development and Improvement Plan (SDIP) priorities.*

These funds may not be allocated to sites reporting zero LEP students.
