CRIMINAL CONVICTIONS THAT EXCLUDE SCHOOL EMPLOYMENT

Individuals who have been convicted of certain sex and controlled substance offenses are excluded from school employment per Education Code sections 44010 and 44011. The following are the Penal Codes and Health and Safety Code violations that exclude employment in education.

Health and Safety Code former Sections:

Criminal Convictions

In 1997, California enacted two laws that impose significant obligations on school districts to review the criminal history of applicants and current employees. This law eliminated the exception for substitute and temporary personnel from fingerprint requirements and prohibits the employment of any person until DOJ completes its check. This statute does not apply to secondary students who are employed in temporary or part-time positions in the school that they attend. The legislation requires criminal background checks of employees of school contractors who will have any contact with students. School district MAY request DOJ to provide criminal offense information on volunteers, but it is not required. Any person who has been convicted of a violent or serious felony cannot be employed in accordance with Education Code 44332, 44332.5, and 44332.6.
