#### 10.0 PUBLIC HEARING

10.1 Determination Hearing for Charter Renewal for St. HOPE Public 7 (Amanda Goldman)

President Phillips opened the public hearing on the petition that was submitted to the district to renew St. Hope Public School 7 charter for a five-year term beginning on July 1, 2025 and ending on June 30, 2030. This is an action item. Amanda Goldman shared details regarding the review process for the renewal petition, and discussed procedures for the public hearing. Lisa Ruda shared PS7 highlights, that PS7 meets renewal criteria, report findings, looking ahead, creating a positive school culture, professional development and support, actions, strengthening financial reporting, and commitments.

#### Board Comment:

Member Jeane appreciates the documents provided, and careful vetting and process. Member Jeane appreciates that there are direct responses to every piece of the concerns that have been brought forward. Member Jeane shared that it has been amazing to hear all the amazing stories, successes of PS7, and the programs that these schools are offering. Member Jeane would like to build a better partnership. Member Jeane wanted to know how we can put things into place to ensure that there are annual reports, check-ins, and consistency. Member Jeane would love to see continued growth on the plans.

Member Rhodes asked Amanda Goldman to clarify approval with conditions.

Member Jeane would like to hear reports on governance, fiduciary, generally accepted accounting practices, more on the employee process, and programmatic aspect to look at the curriculum adoption cycle, and suspension and expulsion policies.

Member Singh clarified that a yes with conditions is still a yes. Member Singh sees this as an opportunity to build a partnership, and will allow them to have a stronger relationship.

Member Phillips shared that if the Board is considering renewal, they have to look at the documents in the packet stating approval, approval with conditions, or denial. Member Phillips clarified that the Board's concern is being able to track the changes that PS7 agreed to make.

Member Jeane clarified her concern around the governance for PS7. Member Villa clarified that if this item is approved with conditions, these types of items can be built in the MOU, so they can have discussions and build out from that.

Member Kayatta is agreeing with how the Board is starting to lean, which is approval with conditions. Member Kayatta didn't think it would be fair to bring in information out of left field. It had to be clear with the governing Board with what is expected of PS7 to get the renewal, and if they achieve that, they would get the renewal. It's not that they do not acknowledge that there is some history there that is troubling, or that there are concerns that remain today, but it's about working together to improve the schools, and their oversight over the schools. Member Kayatta shared that most importantly, it's about continuing to offer educational options to our Black students that are not being met with many of our other schools. Member Kayatta appreciates St. Hope's reponse. Member Kayatta mentioned one of the public comments, and does think that they need to get to a rigorous oversight role, and he thinks that what is being described here. Member Kayatta shared that when we look at approving with conditions, he would like it to be formalized, and can put it in the MOU or resolution to make sure that they can ensure compliance.

Member Phillips asked for clarification around the renewal with conditions and the MOU process.

Member Singh shared that he would like the Board to give the authority to Superintent Allen and Ruda the opportunity to work together on drafting the MOU.

Member Villa agreed with Member Singh and shared that we do need to have a partnership and conversation on a more detailed explanation with dates for a more solidified and solid MOU that both parties can work together off of.

Member Singh made a motion to adopt Resolution No. 3439 conditionally approving the petition subject to the findings of fact in the Staff Renewal Report and subject to full satisfaction of the following conditions, which must be met by the Charter School no later than the deadlines specified below.

The MOU must be created by July 1, 2025. The MOU will specify the conditions and timelines.

#### Board Comment:

Member Jeane shared that the one additional condition that really hit her heart as a high school teacher, and hit her heart with the week that we have had as a nation around safety on school campuses, and the importance of that. Member Jeane would like to see a condition around the importance of the high school safety program that needs to be in place, so that staff and students know what to do in case the unimaginable has to occur. In addition to the ones that Member Jeane mentioned previously

around governance, fiduciary, programmatic, and employees, she would like to add something around safety.

Member Chueh-Griffith referenced an article that was published in the Sac Bee last month. Member Chueh-Griffith thanked all the students that came out and to those who spoke and shared their perspectives. Member Chueh-Griffith shared that she hopes that Sac High and SCUSD can move forward and work more in a collaborative way.

Member Singh restated that that a yes with conditions is still a yes. Member Singh would like to continue to figure out how to work together, and if they do move forward, he would like our superintendents to work together collaboratively.
