Part B - Bidder Questions

QUESTION #1: T1 power – Please confirm power to be integrated in the middle of the table. Please confirm power and data needs.

RESPONSE: Power to be integrated into the middle of the table. Provide (4) power outlets and no data.

QUESTION #2: MF7 is listed on the furniture specifications catalog but not in the Excel sheet. I am assuming these are the "MF8 Monitor arms" called out on DS1-DS3. Can you confirm?

RESPONSE: Monitor arms are included as part of the desking system and not listed separately in the spreadsheet.

QUESTION #3: ST1 was removed on the addendum posted but is still in the addendum Excel (ad1.07 attachment f proposal). Would you like us to use the ST2 product for ST1 quantities listed on Excel?

RESPONSE: The product that was specified as ST1 has been discontinued by the manufacturer. Please use ST2 in all locations previously noting ST1.

QUESTION #4: On the Ad1.07 Excel McCoy quantities D2 notes "provide modesty panel." Can you confirm that D1 does not need a modesty panel included?

RESPONSE: All height adjustable desks (D1 & D2) to include a modesty panel.

QUESTION #5: D4 Student Desk – in the spec it asks for a 3" tote to be added to the desk, but I noticed in the excel document it is asking for a metal tray. Can you confirm which option you would like to move forward with for D4?

RESPONSE: D3 to have a metal book box. D4 to have a removable 3" tote.

QUESTION #6: For E106 Classroom – it looks like there are 34 task chairs needed, but no student chairs. Can you confirm that this was an error and that there should be 34 student chairs instead?

RESPONSE: In Room E106 there should be (1) S1 Task Chair and (34) S3 Student Chairs.

QUESTION #7: ST7 & ST8 storage units have a "markerboard back" required for each product, but these products are not compatible with the markerboard back. How would you like us to proceed?

RESPONSE: At ST7 & ST8, provide powder coat finish on back panel, color to be selected by Owner at the finish meeting.

QUESTION #8: D5 Mobile Motum Lectern has asked to provide a cascade laptop shelf, but the cascade laptop shelf is not compatible with the Motum lectern product. How would you like us to proceed?

RESPONSE: At D5, remove option for the cascade laptop shelf.

QUESTION #9: Do the following panels (DS4, DS5, DS6, & DS7) need to be powered? Would you like us to include labor to anchor to the wall if its needed?

RESPONSE: Power to be provided at DS4, DS5, DS6 & DS7, installation of whip to be coordinated with the general contractor. Vendor to include labor to anchor panels to the walls where the condition occurs.

QUESTION #10: Classroom A102 – the floorplan drawing shows 26 student chairs vs. 24 on the document. Please confirm how you would like us to proceed.

RESPONSE: The floor plan for Classroom A102 shows (24) student chairs and (5) task chairs. Please proceed as noted.

QUESTION #11: Classroom A101 - T3 the floorplan drawing has a 72" tables but the excel document shows 60"W. Please confirm how you would like us to proceed.

RESPONSE: Please proceed with 72" tables.

QUESTION #12: Classroom A101 - Drawing shows (4) ST9 units but document asks for (2) ST9 and (2) ST10. How would you like us to proceed?

RESPONSE: Please see Addendum #1 which revises the floor plan to show (2) ST9, (2) ST10 and (1) ST22.
