Comment:	<p>I am a School Social Worker; I am finishing my 20th school year w/the district.</p> <p>I have been encouraged by recent efforts of the district and labor partners working together. Thank you.</p> <p>However, I feel completely disrespected and disregarded as an employee when there are two weeks left on my employee calendar for the current school year AND WE STILL HAVE NO FORMAL COMMUNICATION FROM HUMAN RESOURCES REGARDING OUR RETURN TO WORK DATES FOR 2024/25. I know the district needed to wait to learn from CDE when we would be starting the school year. But there's no excuse for it being an entire month since the August 19th school start date was approved and still ZERO communication for us. How are SCUSD employees to fully use their summer break to relax and recharge--aka employee wellness and self-care--if we are merely guessing what date we are to report to work in August?</p> <p>SCUSD has a recruitment and retention problem... Possibly planning in advance and sending a message of caring for your employees by PLANNING AHEAD might improve that retention rate a bit. There is NO reason why the 2024/25 Employee Work calendars could not have been drafted and then distributed once the First Day of School was finalized.</p> <p>We have high expectations for our scholars--We should have the same high expectation of district leadership. We can do better!</p>

Comment:	<p>The Sacramento LGBT Community Center works to create a region where all LGBTQ+ people thrive; we support health and wellness, advocate for equity and justice, and work to uplift our diverse and culturally rich LGBTQ+ community.</p> <p>Sacramento City Unified School District's Pride Month resolution is an important opportunity to reaffirm the district's unwavering support for the LGBTQ+ community, reject anti-LGBTQ+ violence, and take concrete steps to support and uplift LGBTQ+ students. This resolution signifies an ongoing commitment to the community and as such, it should acknowledge the circumstances that contribute to the startling rates of suicidality, housing insecurity, and health disparities we see within young LGBTQ+ populations.</p> <p>LGBTQ+ youth have been at the receiving end of intensifying violence across the country with hundreds of discriminatory policies proposed and a mobilization of anti-trans school boards seeking to forcibly out students. Though we have not seen these policies within SCUSD, your students experience the same fear felt by youth nationwide.</p> <p>This June, we urge SCUSD to raise the Pride flag and affirm LGBTQ+ students' rights to access facilities and express themselves freely. We urge SCUSD to create greater awareness of the resources available to LGBTQ+ students like those provided by the district's LGBTQ+ Support Services Team. Lastly, we urge SCUSD to recognize that Pride exists thanks to the advocacy of Black and Brown trans folks through the Stonewall Riots and Beyond.</p>
